Dear Solicitor Houser & Chairman McCoy,

Over the past year and eleven months, I have had my ADA accommodation stripped; had no communication between the Board of Supervisors and myself, except via email, outside of the public meetings; delt with board member conflict and their utter disdain for one another; and have also been the subject of harassment, slander, defamation of character, false lighting, discrimination and retaliation in the workplace which has been both frequent and at times severe.

This nightmare has interfered with my focus and productivity both at home and at work. It has also been detrimental to my mental and physical wellbeing. I have given my all to Gallagher Township; however, the situation I currently find myself in has reached a point where I can no longer carry out the duties expected of me.

I know longer wish to hear about my job performance from members of the community where I live or from the residents of Gallagher Township. I no longer wish to have my actions question when I am acting in the best interest of the township and not a personal agenda. I am tired of cleaning up messes created by the members of the Board of Supervisors because instead of communicating with one another, they would rather stab each other in the back. I'm tired of being caught in the middle between two warring factions. I am tired of walking on eggs shells and waking up in a panic in the middle of the night or not sleeping because of it. I'm tired of waiting and wondering what the next PA State investigation to arise is going to be due to the vindictive nature of the members of the Board of Supervisors and their utter disdain for each other. I believe these experiences are something that no one, including me, should have to struggle with at work and at home because of work. It is for all of the above reasons; I hereby tender my resignation effective Friday, December 8, 2023.

I have spoken to Becky Raymond at Raymond's Office Works, LLC in regard to completing the DCED required close out audit. She is the local QuickBooks Expert and is familiar with the township's finances because I have worked with her in the past. She is available and has agreed to complete an audit of the township's finances prior to my leaving. The cost for this will be less than \$1000. I can make all the necessary arrangements prior to my leaving should the board agree to do this. I will also set-up a time to meet with Chairman McCoy to turn in the keys to the building and the file cabinets as well as to provide him with computer passwords.
